Contest Rules

Rules for all contests aired on 91.1 WVNH & WANH 91.5, New Hampshire Gospel Radio and on the nhgr.org website, unless otherwise specified. In the following rules, "91.1 WVNH & WANH 91.5" means New Hampshire Gospel Radio, Inc., which owns WVNH 91.1 FM and WANH 91.5 radio:

Eligibility: NO PURCHASE OR DONATION IS NECESSARY TO ENTER ANY 91.1 WVNH and WANH 91.5 FM contests.

To be eligible to win any prize on 91.1 WVNH and WANH 91.5 you must not have won anything on 91.1 WVNH and WANH 91.5 in the past 30 days or any prize valued at \$600 or more in the past 6 months. Only one winner per household is permitted within 30 days after a household has a winner. Any prize awarded to an ineligible listener will be deemed null and void, and an alternate eligible winner may be named.

All 91.1 WVNH and WANH 91.5 contests are open to all eligible residents 18 or over (unless otherwise specified) living within 50 miles of station transmitter(s). Contestants must possess a valid form of identification bearing the picture of the contestant acceptable to 91.1 WVNH and WANH 91.5 that will be presented to 91.1 WVNH and WANH 91.5 and accepted before the prize is awarded if requested. Employees of 91.1 WVNH and WANH 91.5, its advertising agencies, affiliates, contest sponsors, employees and immediate families of each, and employees of all media of mass communication within a fifty mile radius of the 91.1 WVNH and WANH 91.5 main studio are not eligible to win any contest. Immediate family includes the spouse, great-grandparents, grandparents, parents, brothers, sisters, children, grandchildren, and great-grandchildren of the employee and his/her spouse. This also includes individuals for whom the employee is current legal guardian.

Publicity: Anytime you call the 91.1 WVNH and WANH 91.5 studios you assume that your call will be broadcast or recorded and you grant us permission to broadcast the call or record it for later broadcast.

Use of Personal Information As a winner of a 91.1 WVNH and WANH 91.5 contest your voice, name and/or picture may be used for promotional, broadcast, or internet purposes without any compensation to you.

Prizes awarded are not redeemable for cash. No prize is transferable. No substitution for a prize will be made at the request of winner. 91.1 WVNH and WANH 91.5 reserve the right to substitute a prize of similar value.

Taxes and Governing Authorities: All winners of all contests are responsible for all taxes on prize awarded. All winners of a prize valued at \$600 or more will be required to complete the appropriate tax forms at the 91.1 WVNH and WANH 91.5 studios prior to claiming prize. All winners will be sent a 1099 MISC federal tax form if in one calendar year the prize value of all prizes won exceeds \$600.

Release: Winners will be expected to claim prize at the 91.1 WVNH and WANH 91.5 studios, 37 Redington Road, Concord, NH 03301, between 9:00am – 5:00pm, Monday through Friday (excluding holidays) within 30 days of being notified that they are winners, unless there is an expiration date on prize, which will be specifically stated. Some prizes like concert tickets may be left at will-call venue centers for pick up by winner. Any tickets not left or lost are not the responsibility of 91.1 WVNH and WANH 91.5.

All federal, state, and local laws and regulations apply. Contest is void where prohibited.

Conduct and Decisions: 91.1 WVNH and WANH 91.5 reserve the right to disqualify any entrant if any contest rules are violated in any way.

91.1 WVNH and WANH 91.5 assume no liability for situations, repairs, or incidents arising from any aspect of any prize awarded in any contest. 91.1 WVNH and WANH 91.5, its advertising agencies, affiliates, contest sponsors, employees, and immediate families of each are absolved and shall be held harmless from any action or liability arising from any contest or prize awarded in any contest.

As a licensee of the FCC and a trustee of the public airwaves, 91.1 WVN and WAN 91.5 reserves the right to interrupt and/or discontinue any contest or promotion (and not award the offered prize) at the discretion of 91.1 WVN and WAN 91.5 management if world events, the national mood, or public safety so warrant.

Contestants who register to participate on our website may be required to produce a printed copy of proof of registration before being allowed to participate in the contest.
